# **COMMON REGULATION FOR THE FIVE YEAR INTEGRATED DOUBLE DEGREE LL.B. (HONORS) COURSES**

(As per Bar Council of India Rules of Legal Education 2008 and approved by the Board of Studies Meeting held on 17th September 2018)

## **1. Title of the Programme**

There are three Five Year integrated double degree LL.B Courses offered by the affiliated Colleges under M.G University. The nomenclature of the courses are as follows

- (1) Five Year Integrated B.Com LL.B (Hons.) Degree Course
- (2) Five Year Integrated B.A LL.B (Hons.) Degree Course and
- (3) Five Year Integrated BBA LL.B (Hons.) Degree Course.

## **2. Duration of the Course**

- a) The course shall consist of regular study for a minimum period of 10 semesters in five academic years, after plus two.
- b) The course of study shall be by regularly attending the requisite number of lectures, tutorials and practical training.
- c) The 1st, 3rd, 5th, 7th and 9th semesters shall ordinarily be from 1st September till January 31st. The remaining semesters shall be from 1st February till 31st August, subject to changes if any notified by the Government of Kerala and other authorities; from time to time. The periods are inclusive of the time for examinations.

**3. Medium of Instruction :** The medium of instruction and examination shall be English only.

## **4. Number of Seats**

Number of students to be admitted each year and the number of batches shall be decided and notified by the University from time to time, based upon the Rules, instructions and notifications issued by the Bar Council of India and the Government of Kerala.

## **5. Eligibility for Admission**

An applicant who has successfully completed Senior Secondary School Course ('+2') or equivalent (such as 11+1, 'A' level in Senior School Leaving Certificate Course) from a recognized University of India or outside or from a Senior Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the Government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the programme of the Centers of Legal Education.

Provided that applicants who have obtained +2 Higher Secondary Pass Certificate after pursuing studies in distance or correspondence method (10+2 Pattern) shall also be considered as eligible for admission in the Integrated Five Years Course.

Explanation- The applicants who have obtained 10+2 or Graduation I Post graduation through Open Universities system directly without having any basic qualification for pursuing such studies are not eligible for admission in the law course.

#### **6.Prohibition to register for two regular courses of study**

No student shall be allowed to simultaneously register for a law degree programme with any other graduate or post graduate or certificate course run by the same or any other University or an Institute for academic or professional learning excepting in the integrated degree programme of the same institution:

Provided that any short period part-time certificate course on language, computer science or computer application of an Institute or any similar course run by a Centre for Distance Learning of a University, shall be exempted.

#### **7. Minimum marks in qualifying examination for admission**

Bar Council of India will from time to time, stipulate the minimum percentage of marks not below 45% (without rounding) of the total marks in case of general category, 42% in the case of OBC and 40 % of the total marks (without rounding) in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 Examination in case of Integrated Five Years Course for the purpose of applying for and getting admitted.

Provided that such minimum qualifying marks shall not automatically entitle a person to get admission into an institution, unless the applicant fulfils other institutional criteria notified by the institution/University concerned or by the Government concerned from time to time to apply for admission.

#### **8.Procedure for Selection**

- 1) Admission to the course shall be governed by the Acts, Rules, Regulations and Notifications in force and issued by the Government, University and other Statutory Authorities at the relevant time.
- 2) Admission to the course in Government Law College under the University at present shall be based on the entrance examination being conducted by the Commissioner of Entrance Examinations, Government of Kerala. The students will be allotted and admitted to the Colleges after the centralized counselling to be conducted by the Commissioner for Entrance Examinations, Government of Kerala.
- 3) Admission and all other matters relating to 5 Year Integrated LL.B (Hons.) Courses in Law Colleges affiliated to the University shall also be governed by these regulations.

## **9.Fee Structure**

A student shall pay the fees prescribed by the University and the Government from time to time.

## **10.Age on Admission**

Subject to the conditions, stipulated by the Bar Council of India, Mahatma Gandhi University and the norms fixed by the Government of Kerala on this behalf; the maximum age for seeking admission into a stream of Integrated Double Degree Bachelor of Law Degree Program, shall be limited to twenty years in case of general category of applicants and to twenty-two years in case of applicants from SC, ST and Other Backward Communities. The age shall be reckoned as on last date of application for entrance examination or last date of application for admission, if admission is not based on entrance examination.

## **11. Semester System**

The course leading to integrated double degree shall be conducted in semester system, not less than 18 weeks in double degree integrated course with not less than 36 class hours per week including tutorials, moot room exercise, seminars and other practical papers.

Provided there shall be at least 30 lecture hours per week.

Provided further that University is free to adopt trimester system, with appropriate division of courses per trimester, with each of the trimesters having not less than 12 weeks.

## **12.End Semester University examinations and attendance requirements**

No students shall be allowed to take the University examinations at the end of each semester in a subject if the student concerned has not attended minimum of 75% of the classes held in the subject concerned as also in the moot court exercises, tutorials and practical training conducted to the subject taken together, separate 75% attendance is also required in each of the compulsory clinical courses.

Provided that if a student for any exceptional reasons fails to attend 75% of the classes held in any subject, the University may condone the shortage of attendance as per existing rules.

Provided further that, a list of such students who are allowed to take the examination, with reasons recorded, be forwarded by the University to the Bar Council of India before the student is allowed to appear for the concerned semester examination.

Provided further that the conduct and progress of the student should be satisfactory.

### **13. Prohibition against lateral entry and exit**

There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated double degree course, at any intermediary stage of integrated double degree course.

No student shall be permitted to change course after the commencement of the 1st semester of the course in which the student is admitted.

### **14. Uniform Identity Number of Students and Faculty**

University and its approved institutions registering students for law courses shall send particulars (as prescribed in the schedule X of Bar Council of India Rules of Legal Education, 2008) of its registered students and faculties to the Bar Council of India for the purpose of building up of uniform data of the faculty and the students of law and for issue of Uniform Identity Number to students and faculty against a fee prescribed by the Bar Council of India from time to time.

### **15. Annual Report and Return**

All approved Centers of Legal Education of the University whose degree is approved for enrolment shall submit to the respective University with a copy to the Bar Council of India an annual return in the form prescribed in Schedule VIII, Rules of Legal Education, 2008, in hard and soft copy at the end of its annual academic session.

CURRICULUM OF THE FIVE YEAR INTEGRATED DOUBLE DEGREE LL. B  
(HONORS) COURSES

(SCHEME OF SUBJECTS)

**16.LL.B (Honors) Courses**

Curriculum shall consist of 20 compulsory Law subjects, 08 Law Papers for Honors Degree, 06 Law papers in Optional subjects and 04 Clinical papers in Law. Eight Honors subjects and Six Optional subjects are chosen, and offered by the affiliated colleges, from among the General Elective Courses; by complying with The Bar Council Rules of Legal Education, 2008. The eight elective courses shall be chosen from various groups shown as Special Elective Groups viz.. Constitutional Law, Business Law, Law and Agriculture, Intellectual Property Law and such other groups introduced by the University/Bar Council from time to time depending upon the availability of infrastructural facilities.

Considering the limitations of infrastructure, availability of Faculty, and the nature of the basic degree being integrated; eight papers are taken from multiple of groups (Honours shall be in Law) to be offered initially, in the Law Colleges under the University at present.

**17.University's power for additional subject/group**

Provided that the University may add to the above list of subjects as well as a New Group of subject specialization with such papers as may be stipulated from time to time. Students in the general law course have to take not less than six papers from any three or more groups. In case of specialization or honours in any specific group, the college has to take at least eight papers from one group over and above six optional papers in other groups.

**18.Examination and Promotion**

1. There shall be a University examination at the end of each semester. Candidates securing not less than the prescribed attendance in each paper as mentioned in Clause 12 of these Regulations shall alone be admitted to the examination.
2. For each written paper carrying 100 marks, 25% shall be set apart for being awarded by way of internal assessment and 75% marks for the written external examination. Internal assessment shall be made on the basis of overall performance during the semester such as regularity of attendance, preparation and presentation of assignments, test paper scoring and class room participation.
3. The performance in practical training papers shall be assessed internally by a team of three faculty members.
4. A candidate who is registered and is entitled to be presented for the examination in a semester shall alone be eligible to pursue the studies for the next semester of the course.
5. There shall be a viva-voce at the end of tenth semester examination which may cover

all the law courses taught for the whole programme. The Viva Board shall consist of the Chairman and two examiners from the law with a minimum of 10 years experience and at least one of whom shall be a practicing lawyer with 10 years experience. A candidate admitted for this course shall complete the programme within a period of eight years from the date of admission.

6. A candidate who has failed in a paper shall be eligible to write the paper in the subsequent regular examinations alone.

#### **19. Pass minimum and classification**

1. A candidate who secures not less than 40% marks in the external examination separately and fifty per cent (50%) in the aggregate of the total marks for that paper shall be declared to have passed the examination in that paper.
2. A candidate who passes in all the papers and secures 50% or more of the aggregate marks for all the ten semesters but less than 60% shall be declared to have passed whole examination in second class.
3. Successful candidates with 60% marks and above in aggregate for all the ten semesters shall be declared to have passed the whole examination in first class.
4. Successful candidates with seventy-five percentage marks or above in the aggregate for all the ten semesters shall be declared to have passed the examination with distinction provided he/she passes all the examinations within the period of whole programme.
5. Ranking shall be done on the basis of marks obtained by the candidate in the whole examination passed in the first chance.

#### **20. Pattern of question papers and distribution of marks**

- (1) Out of the 100 marks for each paper, 25 marks shall be set apart for internal assessment.
- (2) The remaining 75 marks for University examination shall be distributed as follows:

Part (A) : Short answers	: 15 marks (3 marks x 5 questions)
Part (B) : Problems/short essays	: 30 marks (10 marks x 3 questions)
Part (C) : Essays	: 30 marks (15 marks x 2 questions)

#### **21. Internal assessment**

The internal assessment marks shall be distributed as follows:

1. Attendance : 5 marks
2. Classroom assignment : 10 marks (5 marks each) (Written and Oral Presentation)
3. Test paper : 10 marks
4. Total : 25 marks (Maximum)



**Attendance** - Separate attendance shall be maintained for each subject by the teachers concerned; either manually or in electronic form. Attendance report shall be published by the teachers before the seventh day of the succeeding month. Complaints in writing shall be preferred to the Principal I Head of the institution within two days of publication.

Students representing the College/University in academic and extra-curricular activities, with the prior written permission of the head of the institution, may at the discretion of the staff council, be granted maximum of ten days attendance per semester.

Marks for attendance shall be granted as follows:

(i)	Below 75% attendance	:	nil
(ii)	75% to 79%	:	1 mark
(iii)	80% to 84%	:	2 marks
(iv)	85% to 89%	:	3 marks
(i)	90% to 94%	:	4 Marks
(ii)	95 % and above	:	5 Marks

2. **Test Paper-** At least one test per paper shall be conducted by the teacher concerned. The date for the test shall be notified one week in advance absentees shall not be entitled for re-test normally. Exceptional cases on medical and similar grounds may be considered by the staff council. The marks will be published in the class within 15 days of, the test and students can obtain photocopies of the answer script, if required, at their expense. The answer scripts shall be retained by the teacher till 90 days after the test; unless otherwise specifically directed by the authorities, after which period, the teacher shall be free to dispose such answer scripts in whichever manner he/she deems fit.

3. **Classroom Assignments-** Every student shall write an assignment on each subject based on the topics assigned, and directions given by the teacher.

Alternatively, the teacher has the discretion to direct students to participate in seminars/debates on the subject.

Written assignment has to be submitted: 50% marks will be for content and the remaining 50% for presentation.

Internal assessment marks will be published in the notice board by the teacher within 15 days after the end of each semester.

The classroom assignments submitted by the students shall be retained by the teacher till 90 days after the end of the semester, unless otherwise specifically directed by the authorities, after which period, the teacher shall be free to dispose such assignments in which ever manner he/she deems fit.

4. **Grievance Redressal Cell** - A Grievance Redressal Cell constituted by the head of the institution shall examine written complaints in respect of internal assessment. Complaints shall be preferred within 5 days from publication of the marks; and the decision of the cell shall be final.
5. **No redoing of internal assessment** - Marks once awarded in the internal assessment shall be final and no application for redoing of internal assessment shall be entertained on any ground after the end of the semester.

## **22. Compulsory Internship**

As per the Rules of Legal Education laid down by the Bar Council, 2008, each five year student has to undergo an internship for not less than twenty weeks to carry out legal studies under Non-Governmental Organizations, trial advocates, appellate advocates, judiciary, legal regulatory authorities, legislatures and Parliament, other legal functionaries, market institutions, law firms, companies. Local Self Government and in other legal institutions where such training can be imparted to such students. Students cannot undergo internship in any year continuously for more than four weeks. All students are expected to undergo training under trial and appellate advocates not more than twice.

The Bar Council has also stipulated that each student shall keep an Internship Diary. The Internship Diary has to be prepared and kept by the student in such a manner so that the evaluator may be able to assess the cumulative performance of the student. The Diary shall contain the details of training a student has undergone, the total number of days of each session of training and the nature of work done by the student/training imparted to him. After each spell of such internship, the record, prepared by the student in his own handwriting, shall be signed by the head/chief of the institution where he has undergone training, and the faculty-in-charge of him. The students shall be guided and evaluated by the faculty as appointed by the Principal. A student who has to complete more than four weeks of internship shall not be promoted to the tenth semester. He can re-join the course only after completion of the required weeks of internship in the subsequent batches:

Provided that, after each spell of internship, the evaluator/s shall assess the performance of the students, on the basis of the days of his attendance in the internship, involvement and awareness about the work accomplished and also the preparation of the records. The evaluator shall record the assessment objectively after perusing the record of internship. A student who has satisfactorily completed the internship shall alone be eligible to be promoted to the next semester/year. A student who has not satisfactorily completed the internship programme has to redo the same with their subsequent batch.

Provided further that, being a component of the Clinical paper IV, attending the chamber of lawyers and observing trials in two cases shall be confined to the tenth semester and its record shall be prepared separately in the Record of the Clinical paper IV, ie., FL 38 Moot Court Exercise and Internship. Attending the lawyer's chambers before the tenth semester will not be reckoned for the purpose of FL 38.

The Internship Record shall contain details of training for 20 weeks (ie., excluding the training for FL 38). While assessing the candidate for FL 38, due weightage shall be given to his performance I involvement in the compulsory internship of the previous semesters as evidenced by his Internship Record.

### **23.Re-admission**

Re-admission to each semester shall be according to the availability of seats in the concerned semester. This shall also be subject to rules framed by the University and Government of Kerala from time to time. Application for Re-admission shall be submitted to the University, 3 weeks before the commencement of the Semester to which the applicant seeks for admission. Provided that only those students who have dropped out/been detained/obtained transfer certificate or discontinued from any semester of Integrated Five Year LL.B (Hons.) course as per these regulations alone will be eligible for re-admission.

### **24.Transfer from other Universities/Colleges**

Students who are registered for LL.B Courses in any other University shall not eligible for inter University transfer. There is no Intra University transfer from Self-Financing/Private Law Colleges to Government Law College. Intra University transfer in all other cases shall be subject to the recommendation of the Principals of both colleges and in accordance with University Rules.

**REGULATIONS AND SCHEME OF EXAMINATION FOR THE  
L.L.M P.G.COURSE . 2021 Admission onwards (SEMESTER SYSTEMS)**

Objectives: The LLM P.G. Course offered by the University intends

- (i) to train law students to critically analyse and evaluate the laws of different legal systems
- (ii) to produce experts specialised in various legal spheres and
- (iii) to produce efficient academicians, lawyers and to manage specialised legal domain.

1. Duration: The LLM P.G. Course shall be of two years duration, consisting of four semesters. A semester shall consist of not less than 90 working days.
2. Nature of the Course: The Course is offered on a full-time regular basis and hence the students have to dedicate the course period exclusively for prosecuting their studies during the course period.
3. Master of Law: The options for branches of law offered for the LLM Course shall be as follows:  
Branch I - Commercial Law  
Branch II - Criminal Law  
Any other branch that may be added by the University in future.

**Admission Strength in the Course:** The number of students to be admitted to the course shall be as per the norms of the University and Government adopted from time to time. A branch of law will be offered subject to the availability of at least 30% student strength in that branch. If the total strength of the students admitted is less than the 30% of the total number sanctioned by the government, it will be the discretion of the institution concerned as to whether or not to opt one branch of Law offered for LLM Course in terms of optimum strength. However, if an institution offers only one branch of law, the student strength mentioned above will not be applicable.

**Qualification for Admission;** A candidate who has passed the LLB Examination in the regular mode of the Mahatma Gandhi University, or any other University recognized as equivalent thereto and also approved by the Bar Council of India shall be eligible to be considered for admission.

Admission procedure and fee structure: The prospectus issued by the University/Government periodically will be prescribing the procedure for admission and the fee structure.

Curriculum of LLM Course :

- (i) The first semester will consist of 4 compulsory papers including Teaching practice and Project Work and applicable to all branches of law.
- (ii) The second semester will consist of 4 papers of the concerned branch.
- (iii) The third semester will consist of 3 papers of the concerned branch.

- (iv) The fourth semester will consist of two papers of the concerned branch besides dissertation and viva voce.

**Conduct of the Course at the institutional Level:** A Senior Law Teacher having not less than 10 years PG Teaching experience and considerable research experience, assigned by the Principal of the institution shall head a Panel along with two other Senior Teachers who are having like qualifications, to supervise the conduct of the PG Course in the institution. If faculty member(s) of the above description is not available in an institution, the Principal shall entrust the same with senior law teachers having substantial teaching experience and capable to accomplish the task.

**Teaching Assignment in under-graduate classes:** Every Student has to necessarily engage six Teaching Assignment Sessions for the students of under-graduate classes in law in the respective institutions in every course/subject in every Semester. The respective teacher evaluator should be mindful of the feed- back from the learner students collected using appropriate methods and also the peer -evaluation while awarding marks in the respective Internal Assessment component.

Requirement to Fulfil internal assessment component (ii) for the Course in Research Methodology in the first semester: The students who are to fulfil the requirement of the component (ii) of the Internal Assessment viz., Assignment and Presentation in Course 4 - Research Methodology, the students are expected to write and present a proper Research Proposal for a topic of their choice which has to be presented to fulfil the requirement.

End Semester External Examination

There shall be an end semester external examination in each semester for all courses (papers) other than practical courses (papers). The Aggregate Marks for such external examination of each paper will be 70.

**Practical Examinations:**

**(i) Teaching Practice**

**(a) Assignment of the Topic**

A Panel of Law Teachers of the institution constituted by the Principal having considerable PG teaching Experience including the teacher panel in charge of the PG Course, shall be entrusted with the task of selecting topics for the teaching practice session of the Students. It is preferable to have a topic bank for the same at the institutional level revised at regular intervals keeping in view the contemporary developments in the sphere of law. Every student has to be given a choice of two topics through lots of which one topic shall be selected by the student based on respective preference for the teaching practice session. The topics have to be assigned to the students, a minimum of 7 days prior to the day of teaching practice. A student has to deliver a Lecture, on a topic assigned, before the Board of Examiners constituted by the University with or without teaching aids. The duration of the teaching practice shall be

20 minutes and 5 minutes question/answer session, which may be extended with the approval of the Chairman of the Practical Examination Board.

## Evaluation

The Board of Examiners for first semester to evaluate Teaching Practice shall consist of Chairman and two members of which one shall be an external expert member. The Chairman and members shall be senior law teachers, having more than 10 years of teaching experience and research experience and preferably having a doctoral degree in law who are to be appointed by the University. The Chairman of the Board and one member of the Board shall be from Government Law College affiliated to the M.G. University and the Expert Member shall be from the Department of Law, M.G University or a Senior Law Faculty Member from any Department of Law from other Universities in the State or from other Government Law Colleges in the State.

### i. Practical Examination II (Project)

#### Assignment of the Topic

Every student has to prepare a project on a topic duly finalized from among the choices of the student and submit within four months from the date of commencement of the first semester. The general Guidelines for the accomplishment of the component shall be as per the Guidelines.

#### Evaluation

The evaluation of the Project will be wholly external. The Project carries an aggregate of 50 marks which is apportioned as 40 and 10 respectively for evaluation of the Project and viva voce examination respectively. The students shall submit Two copies of the Project to the Principal who in turn shall forward one copy to the University for getting the same evaluated. The Projects shall be evaluated by a Panel of Law Teachers prescribed by the University having considerable PG Teaching Experience and Research Experience from the Department of Law, M.G. University/ Law Departments from other Universities in the state/Government Law Colleges in the State. The viva voce examination for the Project may be conducted by the same Board of Examiners constituted for evaluating Teaching Practice.

**Dissertation:** The Students promoted to the final semester shall register their topic of dissertation in the first month of the commencement of the Third semester itself in consonance with the Guidelines reflected in Annexure II. Three bound copies of the completed Dissertation shall be submitted FIFTEEN DAYS prior to the completion of the final semester. The students shall submit Three Copies of the Dissertation to the Principal which shall be forwarded to the University for evaluation. The Dissertation shall be evaluated by external evaluators from among the Panel of external evaluators prepared by the University which may include faculty members of the Department of Law, M.G University/ Law Departments of other Universities in the state/ Government Law Colleges in the state having substantial PG teaching and Research Experience.

#### Course viva voce:

The Course viva voce will cover all subjects of the course of study as well as the dissertation work. The Board of Examiners for conducting course viva voce examination for both the Specializations shall be the same. The Chairman and members shall be senior law teachers, having more than 10 years of teaching experience and research experience and preferably

having a doctoral degree in law who are to be appointed by the University. The Chairman and one member of the Board shall be from Government Law College affiliated to the M.G. University and the Expert Member shall be from the Department of Law, M.G University or a Senior Law Faculty Member from Law Department of any other Universities in the State or from other Government Law Colleges in the State.

1. No redoing of internal assessment - Marks once awarded in the internal assessment shall be final and no application for redoing of internal assessment shall be entertained on any ground after the end of the semester.
2. Weekly Seminar: The College shall arrange weekly seminars on any working day in every week. Day and time shall be fixed by the college and continued till the end of the semester. All Post Graduate students shall attend the seminar. The object of the weekly seminar is to provide healthy discussion/interpretation of judicial decisions, statutes, rules and other legal principles.

Promotion: Only students who secure the minimum attendance of 75 per cent and above in a semester shall be allowed to appear for the external examinations of that semester. A student who has satisfactorily completed the course of one semester and has registered for the examination of that semester shall be promoted to the next semester.

Classification of Merit: The classification of the Merit is reflected in the tabular form below.

The students who have successfully passed the courses including the practical components in their first appearance alone will be reckoned for rankings in all branches of law. There shall be separate rankings in all branches of law.

**Completion of Arrear Backlog:** The students who are unsuccessful in passing the external examination shall secure a pass in those courses and clear the backlog of arrears within a period of 3 years from the date of completion of the course utilizing the chances available within the said period. No further chance to clear the backlog of arrears if any will be granted.

Transfer between Institutions: There will be no inter-university transfer. Intra- University transfer will be limited to transfer from Government Law College to Self-Financing Law Colleges and between Self- Financing Law Colleges provided the Principals of the both the institutions consent to the same.



## Scheme of LLM Examination:

### 1<sup>st</sup> SEMESTER (Common to all branches of Law)

## **GUIDELINES FOR PREPARATION OF PROJECT WORK FOR FIRST SEMESTER LL.M.**

1. Project based learning is meant to be accomplished as a Curricular Requirement for post-graduate students in Law in their first semester.
2. The requirement of PROJECT is earmarked to acquaint the students with different learning strategies and to integrate the same with the component of Legal Education and Research Methodology employing Social Science Research Tools.
3. Each student shall select TWO topics and shall present the same before a Panel of Teachers nominated by the Principal to finalize the Topics, out of which one of the Topics may be finalized after ascertaining the feasibility-viability standards. The respective intending Guide may also be present in the Panel Discussion for Finalization of Topics. The minutes of the Proceedings shall be recorded.
4. The topics selected for the proposed projects shall possess the scope for APPLICATION of intended knowledge acquisition (Applied Knowledge). Hence pure doctrinal study is not intended in this component.
5. Once the SYNOPSIS is finalised the Project undertaken has to be done within THREE MONTHS. The Project shall be submitted to the Principal not later than completion of four months of the commencement of the first semester.
6. The project shall not exceed 60 pages. The 60 pages will be confined to the study and the rest will be outside the page limit which is to be numbered in Roman Numbers.
7. The evaluation of the Project will be wholly external. The Maximum mark for which a Project will be evaluated is 50 which includes viva voce for 10 marks (40+10)
8. The Research Methodology to be adopted is to be clearly specified at the outset itself and the mode of citation should be in consonance with Indian Law Institute modelled citation/latest edition of Harvard Blue Book of Citations.
9. The typing shall be done in A4 size paper in Times New Roman Font having size 12 with spacing of 1.5 for Body of the Project and font size 10 with spacing of 1 for foot note.

## **GUIDELINES FOR PREPARATION OF DISSERTATION IN THE FOURTH SEMESTER LL.M.**

1. The curriculum of the fourth and final Semester LL.M. Course requires the students to fulfil the component of Dissertation which is to be assessed for an aggregate of 150 marks.
2. The requirement of DISSERTATION in the final semester of the PG Course in Law is aimed to inculcate application of research skills and foster multi layered legal research and legal writing and to translate the same to demonstrable and tangible findings on the chosen respective topics employing Research Methodology with or without employing Social Science Research Tools.
3. At the commencement of the third semester itself each student shall select TWO or more
4. topics and shall present the same before a Panel of Teachers in charge of over viewing the PG Course studies or even before a larger Panel in the institution as shaped. The topic has to be finalized and the Synopsis has to be got approved by the designated Supervising Teacher before the commencement of Fourth Semester.
5. The students shall submit monthly progress Report to the Supervising Teacher and the same shall be countersigned by the Head of the Panel of Teachers in charge of PG Course and properly documented.
6. Three bound copies of the completed Dissertation shall be submitted FIFTEEN DAYS prior to the completion of the final semester. Along with the hard copies, a soft copy of the Dissertation in a CD also needs to be necessarily submitted for enabling plagiarism checking.
7. The Dissertation shall be a minimum of 100 pages.
8. The evaluation of the Dissertation will be wholly external. The Aggregate Maximum mark for which a Dissertation will be evaluated is 150.
9. The Research Methodology to be adopted is to be clearly specified at the outset itself and the
10. mode of citation should be in consonance with Indian Law Institute modelled citation/latest edition of Harvard Blue Book of Citations.
11. The typing shall be done in A4 size paper in Times New Roman Font having size 12 with spacing of 1.5 for Body of the Project and font size 10 with spacing of 1 for foot notes.

## Rules and Regulations

### BSOLS Student Rules

#### Medium of Communication

- In order to boost up oral communication skills in English all conversations between teachers and students inside the campus shall be in English language only. Use of other languages should be an exception.

#### Dress Code

- **Boys:** On working days, boys should wear plain white half sleeve formal shirt with formal black pants, black belt and formal black shoe and black socks. On ceremonial occasions boys should wear white formal full sleeve shirt with formal black pants, black blazer, black shoe with black socks.

**Girls:** On Working days, girls should wear plain white formal shirt with three fourth sleeve and formal black pants and sleeveless waist coat (12 cm from waistline) with executive black shoes only. Hair should be neatly combed and tied up. On ceremonial occasions girls should wear plain white formal full sleeve shirt with black pants, formal black blazer and executive black shoes.

Disciplinary action will be taken against students who are not in full uniform along with the exhibited ID card.

- Boys are expected to keep their hair short and girls are expected to tie up their hair and come in a manner appropriate for the academic environment.
- Students who violate the rule shall be identified during the zero hour from 09.30 AM to 9.40 AM and shall not be allowed to attend the class for the rest of the day.
- In case of any bodily injury, students shall be entitled for relaxation in wearing uniforms with the written permission of the Principal.
- Students who have lost their ID cards should carry a Temporary ID card which shall be issued from BSOLS Office on the payment of the cost.
- Students attending events during holidays shall be in full uniform.
- Students are expected to be in uniform on special day such as Coffee with the Master, Guest Lectures, Legal Aid Clinic days, etc.
- Students who are not in proper uniform shall not be allowed to enter class/campus (as the case may be).

## **Timings**

- Time of arrival – All students shall be inside the classroom by 09.25 AM.
- A student having a genuine reason may be considered by the class teacher for entry into the classroom up to 09.40 AM after which no student is allowed to enter for the 1st hour.
- The gate shall be closed at 10.00 AM every day. The entry of student's vehicles in the campus after 10 am will not be allowed. Students who arrive between 10.00 am to 10.30 am attending the second hour shall be admitted inside campus subject to permission being given from the Reception (Ph. No:9207748070). Once the student is allowed to enter, he/she should meet the aforesaid staff member and get permission in writing which should be submitted to the class teacher during the first break. Class teacher shall review the reason for late entry of the student. In the event of more than three late entries, the matter will have to be reported to the Programme Co-ordinators.
- The gate shall be kept open during all intervals. No permission for entry shall be granted after the interval.
- Out pass shall be issued by the concerned class teacher. Only three out passes shall be issued in a semester without the consent of the Programme Co-ordinator.
- Students are normally permitted to remain in the campus only till 5.00 p.m.
- **Sports:** Students are allowed to play in the ground upto 4.30 pm and gymnasium also upto 4.30 pm

## **Academic Rules**

- Oral Presentation shall be compulsory for all assignments.
- Assignments shall be submitted on the due date prescribed for submission by the subject teacher. Late submission of the assignments will not be allowed.
- Students shall strictly adhere to submission dates prescribed for their assignments in each subject, irrespective of intervening exams or other academic activities.
- Students should be present on time for all their internal examinations. Students shall not be permitted to enter the exam hall after 10 minutes of the commencement of the examination.
- Students creating disturbance of any kind within the examination hall or attempting to engage in malpractices or exhibiting unruly conduct shall have their examination cancelled for that subject and shall be subjected to disciplinary proceedings, wherever found appropriate.
- Student are not allowed to carry their mobile phones and strictly prohibited inside the examination hall.

- There shall be only two internal examinations in a semester. If a student scores 40% and more marks in each test paper best of the two internal test unit be considered for calculation of internal marks. Below 40% of marks, in any of the test papers, average of the two tests unit be takes as internal marks.

In case any student could not appear in any of the two tests or fails to score 40% marks in any of the tests, an additional test paper will be conducted.

### **Attendance**

- Attendance shall be available in the web portal (eportal.bsols.edu.in) for verification. It is the duty of the student to check the portal for their attendance status daily.

Any grievance or claim in respect of marked attendance should be submitted within 3 working days from the date of absent to the concerned teacher. In case of any claim regarding attendance under University Regulations should be submitted before the last day of the month. Late submission of any of the attendance grievances or claim will not be considered.

### **Class Room Rules**

- *Respect to teachers* – Students violating the decorum of the class or disrespecting/obstructing the teacher from exercising his/her duty shall be asked to leave the class. Such conduct shall be reported to the Programme Co-ordinator/Principal and the students shall be suspended from class for one day.
- Use of mobile phones inside the class rooms are not allowed. They shall hand it over at the reception counter or keep it in their bags in silent mode. They can take back phone only when leave the campus.
- ***Penalty for using mobile phones*** –Bringing and using mobile phone during class hours shall be followed by suspension of the student for 2 days. On the expiry of the suspension period, parents should be present to take back the phone and the concerned student shall furnish an undertaking (countersigned by the parent) to the effect that such violations will not be repeated.
- Students should maintain decorum while attending the class and follow class timings strictly.
- Students should request their parents to convey urgent messages, if any, to the BSOLS office for communication to the students.
- Students are not permitted entry into other classrooms.

- The notices shall be read in class and will be put on the general notice board. Short notice intimations to students shall be communicated by the class teachers through the class representatives.

### **External Competitions**

- Students attending external events/competitions may be provided with attendance for the respective days provided they have sought the prior permission in writing from the principal through the teacher incharge to attend the event and have to produce the certificate of participation along with prescribed form for attendance claims.
- If students wish to attend out of state competitions/events they should produce the consent letter of their parents to that effect, in writing.

### **Club Activities**

- All club activities will be held after 3.30 p.m.
- Sports and Arts Day shall be held in the month of August-September subject to the academic schedule of the university and the Law School.

### **Smoking and use of alcohol or narcotic substances**

- If a student is found smoking within the campus or under the influence of alcohol or any other narcotic/psychotropic substances, the student shall be placed under suspension for 5 working days and same shall be intimated to the parents.
- For a second violation, the student shall be dismissed from the college.
- Students are prohibited from bringing to the campus explosives, alcohol, drugs, cigarettes, weapons or any other material, that is capable of causing injury to others or damage to property. Students found violating this rule shall be subject to dismissal from college and the incident shall be intimated to the police.
- Any musical instrument/speakers shall not bring inside the college campus without the prior permission of the authorities.

### **General**

- For any concern relating to a student/students, the hierarchy to be followed for reporting the matter shall be as follows – Class Teacher to Programme Co-ordinator to Principal; and Principal to Director. This has to be strictly followed.
- Loitering, whistling, howling in corridors etc. are strictly banned.
- Students are expected to maintain discipline and appropriate etiquette at all times.
- Students are not permitted to gather and sit in common areas meant for visitors, conference room or in the front area of the Law School building.
- Students are not allowed to bring visitors to campus without the prior approval from the concerned authorities.
- Students are not permitted to hold celebrations inside the campus without the express permission of the college authorities. Permissions



are to be sought in writing, five working days prior to the date of the event.

- Classrooms shall not be used for personal celebrations such as birthday or special day, cake cutting etc.
- Students are not permitted to visit the canteen and Juice centre during class hours.
- Students shall not use the services of the Law School to send or store obscene, defamatory, indecent or otherwise unlawful content.
- Student's vehicles are allowed only up to the designated parking area. Entry of vehicles beyond that point is strictly prohibited.
- Students found destroying or defacing furniture will be asked to replace such items or be fined for the same.
- Tours shall be permitted only after 7th semester. All the prescribed rules and norms of the College as well as Govt. authorities such as Police, motor vehicle Dept. etc. should be strictly followed.
- Crackers or other explosives should not be used on campus. Students violating this rule shall be subject to suspension from the college.
- In the event of violation of any of the rules laid down here in, the student concerned shall be liable to submit an explanation to the Class Teacher in writing. If the explanation offered is found to be unsatisfactory, disciplinary action against the student concerned shall follow.
- Students should wear ID card inside the campus and no student will be allowed in the campus without proper uniform.
- In the midst of the course, if any student discontinued the studies and taking T.C shall have to pay fees of the whole Academic year.
- Students are prohibited from conducting or engaging in any sort of political activities within the Law School premises. Students are not permitted to set up political units in the campus or organize or attend any such meetings inside the Law School premises.
- Indulging in ragging and sexual harassment will lead to disciplinary proceedings including expulsion from the institution and criminal prosecution as per law.
- Students shall not hold any agitations, demonstrations, dharnas etc. inside the campus so that no obstruction/disturbance is caused to the smooth functioning of the Law School and conduct of classes. Students shall not disrupt ongoing classes. Any student on strike who disrupts the activity afore stated is liable to be removed by the police on complaint made by the Principal or Head of Department. This is of course in addition to the entitlement of the Law School authorities to initiate disciplinary proceedings against the erring student who disrupted the academic activity.(Ref: See judgment of the Hon'ble High Court of Kerala in Leo Lukose V. CUSAT and others in WP (C) No.33335 of 2015.)

# **ANTI-RAGGING LAW**

Ragging in any form is strictly prohibited in the college. The Kerala Prohibition of Ragging Act 1998 prohibits ragging in educational institutions in Kerala. Those who are involved in ragging will have to face severe consequences including expulsion from the college/criminal proceedings as per rules.

## **THE KERALA PROHIBITION OF RAGGING ACT, 1998 (ACT 10 OF 1998)**

An Act to prohibit ragging in educational institutions in the State of Kerala.

Preamble: -Whereas it is expedient to prohibit ragging in educational institutions in the State of Kerala;

### **1. Short title, extent and commencement**

This Act may be called the Kerala Prohibition of Ragging Act, 1998.

It extends to the whole of the State of Kerala.

It shall be deemed to have come into force on the 23rd day of October 1997.

### **2. Definition – In this Act, unless the context otherwise required**

(a) 'Head of the educational institution' means the Principal or the person responsible for the management of that educational institution

(b) 'Ragging' means doing of any act, by disorderly conduct, to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or fear or shame or embarrassment to that student and includes

(i) teasing, abusing or playing practical jokes on, or causing hurt to, such student; or

(ii) asking a student to do any act or perform something which such student will not, in the ordinary course, willingly, do.

### **3. Prohibition of ragging**

Ragging within or outside any educational institution is prohibited.

#### **4. Penalty for ragging**

Whoever commits, participates in, abets or propagates ragging within, or outside, any educational institution shall, on conviction, be punished with imprisonment for a term which may extend to two years and shall also be liable to a fine which may extend to ten thousand rupees.

#### **5. Dismissal of student**

Any student convicted of an offence under Section 4 shall be dismissed from the educational institution and such student shall not be admitted in any other educational institution for a period of three years from the date of order of such dismissal.

#### **6. Suspension of student**

Whenever any student or, as the case may be, the parents or guardian, or a teacher of an educational institution complains, in writing, of ragging to the head of the educational institution, the head of that educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint, enquire into the matter mentioned in the complaint and, if, prima facie, it is found true, suspend the student who is accused of the offence, and shall, immediately, forward the complaint to the police station having jurisdiction over the area in which the educational institution is situated, for further action.

Where, on enquiry by the head of the educational institution, it is proved that there is no substance prima facie in the complaint received under sub-section (1), he shall intimate the fact, in writing, to the complainant.

#### **7. Deemed abetment**

If the head of the educational institution fails or neglects to take action in the manner specified in section 6 when a complaint of ragging is made, such person shall be deemed to have abetted the offence of ragging and shall, on conviction, be punished as provided for in Section 4.

#### **8. Power to make rules**

The Government may, by notification in the Gazette, make rules for carrying out all or any of the purposes of this Act.

Every rule made under this Act shall be laid, as soon as maybe after it is made, before the Legislative Assembly, while it is in session for a total period of fourteen days, which may be comprised in one session or in two successive sessions, and if before the expiry of the session in which it is so laid, or the session immediately following, the Legislative Assembly makes any modification in the rule or decides that the rule should not be made, the rule shall, thereafter, have effect only in such modified form or be of no effect, as the case may be; so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule

## **9. Repeal and saving**

The Kerala Prohibition of Ragging Ordinance, 1998 (2 of 1998), is hereby repealed.

Notwithstanding such repeal, anything done or deemed to have been done or any action taken or deemed to have been taken under the said Ordinance shall be deemed to have been done or taken under this Act.

### **ANTI -RAGGING COMMITTEE AND ANTI -RAGGING SQUAD:**

The Institution had constituted the Anti –ragging committee in compliance with the UGC regulations on the menace of ragging in higher educational institutions. This committee is to prevent and prohibit the menace of ragging of any type.

#### **Role and Responsibilities:**

Anti-Ragging committee is to ensure compliance with the provisions of the regulations as well as the provisions of any law for the time being in force concerning ragging.

To monitor and oversee the performance of the Ant-ragging Squad in prevention of ragging in the institution.

#### **Functions of Anti- Ragging Committee and Anti -Ragging squad:**

The committee will educate the students at large by adopting various means about the menace of ragging and related Punishments there to.

Disseminate information on Anti ragging rules & regulations.

An Anti- Ragging Squad is formed and will be working under the monitoring of Anti-Ragging committee.

The functions of Anti Ragging squad is to keep a vigil and stop the incidences of ragging, if any, happening/reported in the places of student aggregation including classrooms, Canteen, Buses, Grounds, Hostels, etc.

They shall work in consonance and guidance of Anti- Ragging committee. If anyone suspects or come to know about, or becomes a victim of ragging inside or outside the campus can contact any of the anti-ragging committee members.

The Anti-Ragging Committee of the institution shall take an appropriate decision upon the violation of rules.

The frequency of meeting will be once in a semester. In addition meeting of all members of cell can be convened, if required.
