License

License Fee

Training and Support services

- 1. The developer shall, at their expense, provide the staff/ employees of the licensee with the initial training services necessary and desirable to operate the software, at licensee's offices and on days and times the parties agree to in writing.
- 2. The developer shall provide support service to the licensee during the tenure of the license/agreement through telephone or electronic means at normal business hours in order to help the license to locate and correct problems with the software. Business hours means 9 am. to 6 pm.

Fixes and patches.

The developer shall provide the licensee at the developer's sole expense, with bug fixes and code corrections to correct software malfunctions and defects in order to bring the software into substantial conformity with its operating specifications. However, the developer may not be required to, provide these maintenance services if the licensee has attempted modification of the software of its own or is in default.

Data loss

- (i) The licensee shall be solely responsible for data storage , protection, data base management and preserving back up of data all times.
- (ii) The licensee shall take all efforts to keep and maintain their data properly stored and protected while being processed using the licensed software and the developer shall not responsible for any data loss due to lack of proper care and caution by the licensee.
- (iii) The developer's liability to any data loss due to malfunction of the software is to be decided by case to case base but limited to the sum of licensee fee cumulatively in total .

Transferring Data

Data of the licensee will be exported to the developer and it has to be added as required by the licensee. The whole data has to be transferred in excel format at the end of license agreement, at the end of academic year or whenever it is required.

Updation

The developer has to do periodical modification/ updation whenever required by licensee expect structure and number of core modules as enumerated in the Schedule 1 of these presents, as part of license fee.


The developer has to provide to the licensee the whole or part of the data extent to one year as required by the licensee.
