- 3. Whereas the Second Party is an established provider of the aforesaid services,
- 4. Whereas the First Party and the Second Party have mutually agreed to install the biogas plant subject to the scope and conditions of work, with effect from the the 4th day of July 2020,
- 5. Whereas the Scope of work from the side of the Second Party, is the construction of a model biogas plant 4 Cu.M, slurry collection tank of 1.5 x 1 x 1m size, plumbing work approx 125 m length, initial cow dung feeding and supply of an SS double burner stove on the Choondy based campus of the First Party.
- 6. Whereas the estimated COST OF WORK is Rs. 1, 20,000 (Rupees one lakh twenty thousand only) + GST,
- 7. Whereas the cost includes the supply of construction materials, construction of one plant, plumbing work and commissioning, is all inclusive,
- 8. Whereas the First Party shall give due permission to labourers and staff to the site, fresh water for construction and for curing, provide space for storage of construction materials, subject to availability.
- 9. Whereas the First Party reserves the right to remove the labourers and staff from the site, if the peace, order or property is harmed in any manner
- 10. Whereas the Second Party undertakes to complete the work within 45 days of the receipt of the work order along with 75 percent of total cost as advance.
- 11. Whereas the work will be deemed to be complete once the burner is fired using the gas generated from the gas plant

12. This agreement comes into effect from the 4th day of July 2020
