

## 1. Purpose of agreement

- Any other activities as mutually agreed


## 3. Joint Activities

All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing, including the necessary budget for the program or activity as the need may arise. institutions shall be fully responsible financially for the activities carried out under its direction or by its staff.

### **5. Intellectual property**

Both parties will ensure that any results and publications originating from this collaboration will be available at The Bharata Mata School of Legal Studies and Carmel College of Nursing.

### **6. Duration and renewal of agreement**

This Memorandum of Understanding shall become effective immediately after being signed by representatives of both institutions, for a period of 3 years and is subject to revision or modification by mutual agreement. It may be extended further by the mutual consent of both the parties.

### **7. Representatives**

Both educational institutions shall appoint its own duly authorized representative to serve as liaison for the execution of this Memorandum.

### **8. Amendments**

- This Memorandum of Understanding may be amended by a written agreement signed by the duly authorized representative from both institutions.
- In the event of any unforeseen incident during collaborative activities in either institution, both parties shall try to negotiate a mutually acceptable solution.
- Should any disagreement arise out of this Memorandum or its application or implementation, both parties shall endeavour to exercise best efforts to sort out their differences.

### **9. Termination of agreement**

This agreement may be terminated at any time during its operation by either party upon written notice to the other no later than 90 days before the termination date. Termination shall not affect the completion of any program or activities underway at the time the notice of termination is given.


